ARCHITECTURAL DESCRIPTION: The stately clapboard Queen Anne house is built on a cement block foundation. The prominent front facade bay section is topped with a pediment that is treated with shingles. The pediment shape of the enclosed porch's roof repeats the classic triangular shape. The porch enclosure appears to date from a later period. Double hung sash windows punctuate the facades. Contrasting wood boards, reflective of the Stick style of architecture, emphasize the house's varied angles and features.

ARCHITECTURAL DESCRIPTION: The impressive two-and-one-half-story clapboard Queen Anne house built on a stone foundation sits on a double city lot. The irregular massing and typical features of the Queen Anne style are carefully preserved in this good example of the style. Various sizes of single sash double hung windows punctuate the facades. The open first story wrap-around-porch is supported by simple classic columns atop masonry pillars. The railings, flanking the steps, are from a later period. The delicately arched second-story porch above the entry was historically used as a sleeping porch. The varied roof lines, the brick chimney, and the prominent front gable with its fish-scale shingles all add to the visual diversity of the house. Like its neighbor at No. 228, it has an element of the Stick style with decorative boards painted in a contrasting color outlining structural features.
